The program is designed to help low-income families in rural areas to obtain suitable, adequate and affordable housing on a rental basis only. Please note that this program does not apply for those who are already on an affordable housing program.

You may be eligible for this program if:

1. You live in a rural area.
2. Your total household income is below the established Income ceilings. The total income must not exceed \$29,000 to \$39,500 (please refer to the Income ceiling table).
3. Your present housing is unsatisfactory and you pay less than 30 percent of your income for shelter, but housing in your area that is suitable and adequate would cost 30 percent or more of your total household income.
4. Your present housing is suitable and adequate, but you pay more than 30 percent of your total household income for shelter.

We will keep your application on file as we have rental units scattered around the province, if any of these become vacant, we will refer to the applications on files and we may contact you for a home interview.
